**Declaration of Personal Property**

**Filing Requirement** – This declaration must be filed with the Assessor of the town where the personal property is located. Declaration of personal property shall be made annually.

If you no longer own the business or personal property, you must return this declaration to the Assessor and provide information related to the name of the new owner of the property or the date your business ceased or to where you moved the business (**see Affidavit next page**). Otherwise, the Assessor must assume that you are still operating the business and still own and have failed to declare your taxable personal property.

If you no longer own a horse in Killingworth, you must provide information regarding the horse and if the horse is in another town, the name of the town and the date moved to that town. (**see affidavit next page**)

If an unregistered motor vehicle (not registered in the Town of Killingworth or not registered at all) is no longer in town, please provide the date and town that the motor vehicle was moved. (**see affidavit next page**)

PLEASE NOTE, ANY PERSONAL PROPERTY ASSESSMENT **CAN NOT BE PRORATED**. THIS FORM IS TO PROVIDE EVIDENCE TO THE TOWN ASSESSOR SO THAT THE PERSONAL PROPERTY MAY BE REMOVED FROM THE UPCOMING GRAND LIST. (Example: If your business is sold, horse is sold/moved or unregistered motor vehicle, sold/moved or registered after October 1<sup>st</sup>, we will remove the account effective the next October 1<sup>st</sup> Grand List year.)
