

**TOWN OF KILLINGWORTH  
BOARD OF SELECTMEN**

Resolution of Discontinuance of  
a portion of Kelseytown Road

WHEREAS, General Statutes §13a-49 authorizes the Board of Selectmen to discontinue a highway or part thereof;

WHEREAS, it has been proposed that the Board of Selectmen consider the discontinuance of the portion of Kelseytown Road that is more fully described as:

The portion of the highway known as Kelseytown Road, located in the Town of Killingworth, County of Middlesex and State of Connecticut, that is approximately 740 feet in length and begins at a point marking the centerline of said road that is approximately 5,380 feet, more or less, from Tower Hill Road at Connecticut Grid Coordinate North 685177; East 1064180 (LAT. N41° 20' 28.744", LON. W072° 30' 58.608") and ends at the Killingworth/Clinton Town Line as shown on a map entitled "PROPOSED ROAD DISCONTINUANCES KILLINGWORTH, CONNECTICUT JAN. 2018 SCALE: 1" = 1000' LAND SURVEY & TECHNICAL SERVICES, INC." which map is to be recorded in the office of the Town Clerk of the Town of Killingworth. In this description the Connecticut Grid Coordinates referenced in the map shall control.

WHEREAS, written notice of the Board of Selectmen's public hearing and regular meeting of January 22, 2018 concerning said highway discontinuance was provided to the following property owners, as required by General Statutes §13a-49(a)(2):

WHEREAS, signs were posted at the highway location to notify the public more than thirty days prior to the Board of Selectmen's public hearing and regular meeting of January 22, 2018 concerning said highway discontinuance, as required by General Statutes §13a-49(a)(2); and

WHEREAS, on January 22, 2018, the Board of Selectmen held a public hearing concerning said highway discontinuance immediately prior to the Board of Selectmen's regular meeting;

NOW THEREFORE, the Board of Selectmen, at its regular meeting of January 22, 2018, hereby:

RESOLVE that the portion of Kelseytown Road that is described hereinabove does not serve public convenience and necessity and therefore shall be discontinued pursuant to General Statutes §13a-49; and

FURTHER RESOLVE that this resolution of discontinuance shall be signed by the Selectmen and serve as the signed writing required by General Statutes §13a-49(a)(1); that this discontinuance shall be brought to the Town Meeting for its approval; and that all necessary actions be taken to effectuate this discontinuance.
