Vice-Chairman Terry Doyle called the meeting to order at 7:00 p.m.

Members present: T. Doyle, E. Auer, J. D'Angelo
Enforcement Officer C. Jefferson was also present.

Members absent: G. Rockwell

Visitors: Jason Nemergut, Tim Pendleton

Minutes: The minutes of the June 14, 2011 Regular Meeting and the minutes of the July 12, 2011 Informational Meeting were approved by a consensus of the members.

Enforcement Officer's Report: Cathie Jefferson reported on the following:

1. A list of the June building permits was distributed to members.
2. The driveway construction proposed for Patrick Drive has been put on hold.
3. A copy of the new Town wetlands map was shown to the members who approved the look of the map.

OLD BUSINESS

A. Town of Killingworth (owner), Parmelee Farm Steering Committee (applicant) wetlands review application for erection of historic school house – 465 Route 81

Members reviewed the proposal for relocating the historic school house formerly located on Route 148. The school house has been dismantled and is on the Parmelee property awaiting reconstruction. Commission members are concerned about the impact of cement trucks crossing the stream on the property during the construction of the school house. The neighbor has been contacted to inquire about accessing the school house site through his property but the Parmelee Farm Committee has not yet heard back from him. Chairman Tim Gannon, via a phone call during the meeting, informed the commission that the concrete will be transported in buckets across the stream so a concrete truck will not be needed for this project. *J. D'Angelo moved, seconded by E. Auer, to treat this review application as an as-of-right review, with the stipulation that the cement truck will not cross the stream. The motion carried unanimously.*

B. A. Forrest King permit application for in-ground pool and deck/patio – 12 Fire Tower Road

Jason Nemergut, PE, presented a new plan to the commission. At the last meeting, members asked Mr. Nemergut to discuss with Mr. King a plan to stop fertilizing and mowing the lawn near the pond and let it grow naturally. Mr. Nemergut presented two plans; one for a lowland planting scheme to use wildflowers and grasses, the other for an upland meadow area with natural grasses and native plants. *E. Auer moved to approve the application with the new seeding detail around the pond. The motion was seconded by J. D'Angelo and approved unanimously.*

NEW BUSINESS**A. BBC123 LLC (owner), Tim Pendleton (applicant) permit application for outbuilding –
56 Wolf Hollow Lane**

Builder Tim Pendleton discussed the application for a 26'x32' outbuilding within 100' of the wetland area at 56 Wolf Hollow Lane. Mr. Pendleton explained that the owner is considering constructing the outbuilding on piers but would like the option to put in a foundation. Commission members would prefer to have the structure on a foundation with a concrete lip and pitched away from the wetlands. Mr. Pendleton will discuss this with the homeowner and provide a plan to the commission if a foundation is agreed upon.
