Chairman G. Rockwell called the meeting to order at 7:00 p.m.

Enforcement Officer C. Jefferson was also present.

Minutes: The minutes of the July 10, 2012 Regular Meeting were approved by a consensus of the members.

Enforcement Officer's Report: Cathie Jefferson reported on the following:

1. Work was started approximately two weeks ago on bridge reconstruction at 392 Roast Meat Hill Road. She has inspected the site and said everything looks good. A representative from The Water Company has been inspecting the site also because it is in the watershed area.

2. She spoke with Roger Nemergut about the pond project at 10 Fire Tower Road. The pond has been dug back about three feet from the original proposal because of the metal, etc. that was found buried there. Photographs of the area were shown to the members. No one expressed any concerns about the slight change in the plan.

3. Copies of the article on the State Farming statutes in the Summer 2012 publication of *The Habitat* were distributed to the members.

4. A Request for Review from C. & M. Little was received for creation of an additional paddock area at 499 Route 80. The applicant would like to know if filling the parcel of land is an as-of-right activity. A copy of the survey map was reviewed and discussed. Commission members will inspect the site on Saturday, August 18th at 9:00 a.m.

OLD BUSINESS

A. J. Villegas – 167 River Road – update on remediation plan

Enforcement Officer C. Jefferson sent a letter requesting information about the remediation plan for the wetlands on the property. Soil Scientist Richard Snarski talked with Mrs. Jefferson about the project. The banks have been cut back to the correct slope. Twelve hundred wetlands plants have been ordered and will be planted soon. Mrs. Jefferson has inspected the site and said what has been done on the site has been done well. She will continue to monitor.

B. D. Coleman - 9 Buell Hill Road

A site walk was conducted on July 12th to review the area of a proposed horse barn. Commission member E. Auer notified the commission that Mr. Coleman has sold the horse so no further review or action is necessary on this project.

NEW BUSINESS

A. Notification from Chester of regulated activity in Chester at Chester Village West

Notification was received about a proposal for a walking path at Chester Village West. Killingworth is an abutting landowner of the property of the proposed activity. There were no concerns about the proposal.


